



**Submission to  
Inquiry into law reform issues regarding synthetic drugs**

**TERMS OF REFERENCE**

That the Legal Affairs Committee inquire into and report on law reform issues regarding the prohibition of synthetic drugs, which are designed and manufactured to have the same effect as prohibited drugs. The Committee will consider the adequacy of current NSW legislation and any other related matters.

*"While banning is the traditional approach to drugs classed as dangerous, a regulatory 'no-man's-land' exists around substances which do not clearly pose a "medium" level of risk. The Eros Association is Australia's adult retail industry association and has been active in putting industry issues to government since 1992. Our members sell many of the products being considered by this committee retail mostly through age-restricted premises and include adult shops, tobacconists and herbal retailers. A number of our members also manufacture and/or import these substances.

The terms of reference for this inquiry are broad covering all synthetic drugs. In our submission we will restrict our comments to currently available synthetic cannabinoids.


Many of our members in NSW have been supplying synthetic cannabinoid substances for a number of years without incident.

Synthetic Cannabinoids are game changers for legislators and for drug policy, in much the same way the internet was for media regulation and censorship. The analogues of cannabis are the tip of the iceberg. Governments have to understand that banning these products means they lose control of them. There is absolutely no jurisdiction in the world that has effectively prohibited these substances.

Currently there are tens of thousands of adults regularly purchasing and using these substances in NSW. Many have now been consuming these substances for a few years. It is naïve to think that if the substances are prohibited from sale that people will just stop using them. Australians will just go off shore and purchase from international businesses, off the internet or from backyard drug dealers. How does this protect public health?

Recent media and reports such as the report by Australia21 "The Prohibition of Illicit Drugs is Killing and Criminalising our Children" confirm that the so called war on drugs is failing and new approaches must be found. The Global Commission on Drug Policy also stated that drug prohibition has failed so it would be ill advised for the NSW government continue down the prohibition path when other more effective options are available.

The Canberra Times cartoonist, Geoff Pryor, said it better than any words can describe in this satirical look at the Howard government's policies on drug prevention.



In the face of what we all know to be true, we urge this committee to consider a different approach to the regulation of synthetic cannabinoids and not go down the same old disastrous road of prohibition that has been the standard response to drugs in NSW for the last 50 years. You don't have to be Einstein to see that there is more illicit drug use in NSW now than there ever has been and that prohibition demonstrably does not work to minimise drug use or to make it safer for the community.

### **The Risk?**

Risks to public health are generally low as when these substances are presented as a herbal smoking blend the substances and have been highly diluted with inert herbal material. Reports of abusive use and adverse reactions have been highly publicised but in reality are extremely rare when you consider the overall number of users.

Toxicological effects of the cannabinoids appear to be minor, as few adverse health effects have been seen except in very heavy users. Anxiety and panic attacks are the only side effects commonly reported from diluted smoking blends, and usually occur in inexperienced users who fail to follow dosage instructions or are not provide with information about usage.

It is very rare for consumers to take large enough doses to cause significant side effects aside from anxiety, though panic attacks have been reported in susceptible individuals following even fairly small diluted doses. Recent media reports have also linked strong coffee with these problems. Eros believes that regulations on the strength of blends and the way in which they can be sold would greatly reduce the frequency and severity of these already rare adverse reactions. Such a strategy

would be a much more effective way of regulating the harms of these compounds than banning them outright.

Synthetic cannabinoids offer governments and regulators the best chance in decades of developing an alternative regulatory model for illicit drugs because they are:

- 1) Significantly less harmful to the user than most other illicit drugs and certainly less harmful than the legal drugs of alcohol and tobacco
- 2) There is already an established retail network of age-restricted premises retailing these substances
- 3) There is widespread acceptance and use of them in the community
- 4) There is widespread use of them for pain relief and other medicinal uses as well for recreation

### **Therapeutic value?**

On this last point it is incumbent on the Committee to at least enquire and report on the medical applications of synthetic cannabinoids. This association has anecdotal evidence from many of people who do not use illicit drugs normally, but have turned to synthetic cannabinoids for relief of a number of common ailments.

Our members have reported that a considerable number of their customers have purchased these substances to deal with a number of health issues including pain relief, depression and to assist in reducing the shaking effects of Parkinson's disease.

We have attached a few random examples of emails, at the end of this submission, that one of our members has received. The reports invariably mention the lack of side effects in the analgesic applications of these substances..

The New Zealand Expert Advisory Committee on Drugs reported in the minutes from their 11 November 2010 meeting (page 9) that there was some qualitative data that suggests that users of these substances find that they have a therapeutic value on a number of conditions including depression, anti nausea and pain relief.

There have also been a number of recent reports that have studied the therapeutic potential of cannabinoids particularly as an alternative to opioid drugs.

It is interesting to note that the relatively recent use of a variety of these substances in smoking blends has led to a resurgence of their use in research.

The other benefit that has been noted is that people are using it as a milder alternative to cannabis.

### **The Toxicity ?**

**"I think although there's an appalling lack of information on the risks and toxicity of these new substances, every indication seems to be that they are not a high or even medium level of risk - there's a low level of risk."** *The Director of the ESR, Dr Keith Bedford New Zealand Herald June 11 2011*

The synthetic cannabinoids have a very low potential to cause death. To date we are not aware of a death caused by these substances.

The synthetic cannabinoids are in most cases unable to induce physical or psychological dependence comparable to that of cannabis, aside from some specified compounds such as JWH-018, (C8)-CP 47,497 and HU-210 which may produce physical or psychological dependence similar to or greater than that of cannabis following prolonged heavy undiluted use.

Eros and its members acknowledge that these substances are not without risk however we strongly believe that regulation in this area is crucial and will be the most effective regulatory avenue to reduce harm. These substances should only be available to adults. The advertising or promotion of them should be strictly limited but consumer information about what they are buying is crucial particularly in regards to dosage and ingredients.

These controls could include:

- A minimum purchase age of 18 years
- Restrictions limiting all advertising (except internet-based advertising) to only the inside of a premises selling restricted substances and a requirement that such advertising not be visible or audible from outside such premises.
- Prohibitions on selling such products from service stations, or from non-fixed premises such as caravans or street carts
- Restrictions on where these substances can be sold ensuring that they are only sold in age restricted venues
- Requirements for all products to contain warning labels, including warning against driving or operating machinery following use, and contact details of the manufacturer and the National Poisons Centre
- Requirements for all products to clearly state the synthetic cannabinomimetic substances they contain on the packet and the recommended dosage

### **Dosage**

Manufacturers and their chemists have recommended the following dosages as an example;

herbal smoking blends mixed, sprayed or infused with (C8)-CP 47,497 at a maximum concentration of 50 milligrams of drug per gram of herbal smoking blend

Herbal smoking blends mixed, sprayed or infused with JWH-073, JWH-019 or JWH-081 at a maximum concentration of 100 milligrams of drug per gram of herbal smoking blend

Herbal smoking blends mixed, sprayed or infused with JWH-250 or 1-pentyl-3-(4-methoxynaphthoyl) indole at a maximum concentration of 150 milligrams of drug per gram of herbal smoking blend

This could be monitored relatively easily in much the same way as TGA officers are currently monitoring “herbal” aphrodisiac products to ensure that they do not contain any prescription drugs for erectile dysfunction.

Imposing restrictions and regulatory requirements on the synthetic cannabinomimetic substances and the permitted ingredients of ‘herbal smoking blends’, could be fairly easily carried out using the processes set out in existing legislation. We would recommend that the committee considers incorporating the regulation of these substances within existing legislation on Non Tobacco Smoking substances in the NSW Public Health Tobacco Act.

There has been anecdotal information about possible harm and side effects but provides absolutely no evidence to support this. Before making broad and draconian decisions on synthetic cannabinoids that will see more young people jailed and an even larger black market than we already have, would it not be in the public interest to commission some original research to get some solid facts and information about the nature and effects of these substances?

**The Eros Association recommends that:**

These substances be regulated within the Public Health (tobacco) Act 2008

The committee commission further research into the therapeutic value of these substances

Regulations be introduced to enforce the display of health warnings and accurate and complete lists of ingredients on packaging, as well as regulate advertising and marketing practices to prohibit marketing to young people or other vulnerable populations.
